Founded in 1991 as an initiative of medical doctors
associations the ECPM intends to ensure pluralism in
health care by

- Promoting the freedom of medical practices and
the patients' freedom of choice
- Communicating with EU politicians and represen-
tatives of health authorities and agencies at the
international level on such matters
- Ensuring that medicinal products prescribed by
medical doctors practicing traditional, complemen-
tary integrative health care are available on the
market
- Promoting high-quality education and training for
TCIH (Traditional complementary and integrative
health) medical doctors
- Providing medical doctors and patients with the
necessary information to make well-informed
choices

30 YEARS

As European federation of medical doctors' associati-
ons representing over 50,000 members who practice
integrative health care in fields like anthroposophic
medicine, herbal medicine, homeopathy, natur-
opathy, neural therapy, manual medicine, Traditional
